United Stations Radio Networks Official Contest Rules

1. Sweepstakes begins on Saturday, May 8, 2022 at 7:00 PM ET and ends on Monday, May 16, 2022 at 3:01 AM ET. One (1) Grand Prize winner ("Winner") will be chosen at random from our list of qualified entries to win a trip for two (2) to see The Chainsmokers in concert as they perform at the XS Nightclub at Encore Las Vegas (the "Event Organizer") on Friday night/Saturday morning, May 21-22, 2022 (the "Prize").
